A public hearing will be held regarding the proposed issuance of these permits on Tuesday, August 22, 2023, at 6 pm at the Clack Health Center, Building #7. Persons wishing to present testimony should contact acpermits@allegheycounty.us or 412-578-8115 at least 24 hours in advance of the hearing. Information will be provided on the Department's permits webpage at <https://allegheycounty.us/AQnotices>. If by 12 pm on Thursday, August 17, 2023, no person has expressed interest in testifying at the hearing, the hearing will be cancelled. If the hearing is cancelled, the Department will provide public notice on the webpage or through the contact information listed above. Comments to previously issued installation or operating permits that are being modified will be accepted on the modified language only.

Also where indicated, this is notice of final action by the Department of issuance, amendment, renewal, or denial of the subject permit. Appeals to final actions may be filed in accordance with Article XI of the County Health Department Regulations and the Pa. Local Agency Law, 2 Pa. C.S.A. 101 et seq., 551 et seq., & 751 et seq., within 30 days of the date of publication of this notice to the Director, Allegheny County Health Department, 542 Fourth Avenue, Pittsburgh, PA 15219.

INTENT TO ISSUE OR MODIFY INSTALLATION PERMITS

DB DATA CENTER PITTSBURGH, LLC - PIT2 (0904-I004), 35 Summit Park Drive, North Fayette Township, PA 15275 for the installation of two (2) identical diesel fueled emergency generators. The installation will result in the following potential increase in emissions: 0.02 tons/yr of particulate matter (PM), 0.02 tons/yr of particulate matter less than 10 microns (PM10), 0.04 tons/yr of sulfur oxides (SOX), 9.91 tons/yr of nitrogen oxides (NOX), 0.02 tons/yr of carbon monoxide (CO), and 0.52 tons/yr of volatile organic compounds (VOCs)

MCKNIGHT REALTY PARTNERS - GRANT BUILDING (0995-I001), 310 Grant Street, Pittsburgh, PA 15219 for the installation of two (2) natural gas fueled boilers to supply steam heating for the office building. The installation will result in the following potential increase in emissions: 0.72 tons/yr of particulate matter (PM), 0.72 tons/yr of particulate matter less than 10 microns (PM10), 0.061 tons/yr of sulfur oxides (SOX), 1.00 tons/yr of nitrogen oxides (NOX), 3.40 tons/yr of carbon monoxide (CO), and 0.56 tons/yr of volatile organic compounds (VOCs).

UPMC PRESBYTERIAN (0224-I004), 200 Lothrop Street, Pittsburgh, PA 15213 for the installation of four (4) identical diesel fueled emergency generators as part of the bed tower expansion at the former Children's Hospital site in Oakland. The installation will result in the following potential increase in emissions: 0.15 tons/yr of particulate matter (PM), 0.15 tons/yr of particulate matter less than 10 microns (PM10), 0.01 tons/yr of sulfur oxides (SOX), 14.98 tons/yr of nitrogen oxides (NOX), 1.66 tons/yr of carbon monoxide (CO), and 0.32 tons/yr of volatile organic compounds (VOCs).

SUNOCO LLC (0965-OP20a), Buckeye Indianola Terminal, 918 State Route 910, Indianola, PA 15051 for the change in ownership from Gladieux Trading & Marketing Co. L.P. to Sunoco LLC as well as for the change in Responsible Official and Facility Contact. The facility consists of a fractionator and associated process heater and boiler. The facility is a minor source of PM, PM10, PM2.5, SOX, CO, NOX, VOC, and HAPs. This permit has been issued as an administrative amendment.
