

NOTICE TO BIDDERS

Sealed Proposals will be received by the Municipality of Monroeville, 2700 Monroeville Boulevard Monroeville, PA 15146 **until 10:00 am on August 29, 2023**, to be publicly opened and read immediately thereafter in the Monroeville Municipal Council Chambers for the following project:

**MONROEVILLE DPW
STREAM RESTORATION
(23-04-STREAM)**

This project consists of improvements to an existing stream and installation of in-stream structures, including log vanes and a crossvane along with areas of bank stabilization, including branch layering, toe wood with branch layering, and gravel bar removal. The project also includes the installation maintenance, and removal of sediment control devices; landscaping; and an associated site restoration to be completed in place. All Proposals must be in the hands of Joe Sedlak, Acting Municipal Manager, Municipality of Monroeville, 2700 Monroeville Boulevard, Monroeville, PA 15146 on or before 10:00 am. prevailing time, August 29, 2023. Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words **Monroeville DPW Stream Restoration (23-04-STREAM)**.

A pre-bid meeting will be held on August 16, 2023 at 10:00 am. The meeting will begin in the parking lot of the Monroeville DPW building located at 200 Starr Drive, Monroeville, PA 15146.

The Municipality will consider bids from Contractors and or Subcontractors that can demonstrate prior completion of at least three (3) natural stream channel restoration projects utilizing natural channel design methods developed by Rosgen within the past three (3) years. Information on the prior projects and contact information shall be submitted with the Bid for review. If a subcontract is utilized, the subcontractors prior work must be submitted with the prime contractor's proposal.

Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreements are on file and open to public inspection at the office of The Gateway Engineers, Inc, 100 McMorris Road, Pittsburgh, PA 15205 where sets of said documents may be obtained starting on August 3, 2023 after payment of \$75.00 for the contract. No refunds will be made to documents purchased. A \$10.00 mailing fee will be applied if a Contractor requests that documents be mailed. Electronic copies will be available free of charge. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Municipality of Monroeville in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract.

Pennsylvania Prevailing Wage rates are required to be paid on this project.

The Proposals must be made to the Municipality of Monroeville, Allegheny County, Pennsylvania, and shall remain firm for a period of ninety (90) days. No Bidder may withdraw his Proposal during the ninety (90) day period without forfeiting his Bid guarantee. Performance, Maintenance, and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement upon acceptance of the Proposal from the successful Bidder. The Municipality reserves the right to reject any or all Bids, or any part thereof, for any reason, and also reserves the right to waive any informality therein. The Bidder is advised that the Municipality will award the contract to the lowest responsible bidder based on the total bid submitted and natural stream channel restoration verification. However, the bidder is advised that the Municipality expressly reserves the right to reject all bids, and specifically reserves the right to award to the lowest responsible bidder a contract for all or any portions of the work listed in the proposal, and in awarding a contract for less than the total work listed, or less than all portions of the work listed, the contract price will be determined from the total quantities for each item listed and the unit price bid for each item listed.
