

**NOTICE TO BIDDERS**  
**HAMPTON TOWNSHIP**  
**ALLEGHENY COUNTY, PA**  
Sealed Proposals will be received by the Township of Hampton, 3101 McCully Road, Allison Park, PA 15101 Allegheny County, PA for the following project: **Bid 1 -Tennis Court and Color Coat Improvements at Hampton Township Park.** The scope of the work will involve items related to the tennis court including, milling, and resurfacing of the existing tennis courts, color coat, removal, and replacement of the existing chain link fence for access, conversion of one tennis court into three pickleball courts, tennis court net posts and nets, pickle ball net posts and nets, additional fencing, and restoration. The approximate area of the courts is 4,250 S.Y. **Bid 2 -Tennis Court Preparation and Installation of Modular Tile Court Surface at Hampton Township Park.** The scope of the work will involve items related to the tennis court including preparation of existing courts including crack preparation and filling, sealing of existing courts, removal and replacement of existing tennis court posts and nets, conversion of one tennis court into three pickleball courts, pickle ball net posts and nets, additional fencing, and restoration. The approximate area of the courts is 4,250 S.Y. All proposals must be in the hands of the Township Manager, Hampton Township, 3101 McCully Road, Allison Park, PA 15101 before 10:00 a.m. prevailing time on Wednesday September 20, 2023 and the same will be publicly opened and read at 10:00 a.m. prevailing time the same day at the Township Municipal Offices, Council Meeting Room. The contract will possibly be awarded on September 27, 2023 at 7:30 p.m. Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words **Bid 1 -Tennis Court and Color Coat Improvements at Hampton Township Park** or **Bid 2 - Tennis Court Preparation and Installation of Modular Tile Court Surface at Hampton Township Park.** Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreement are on file and open to public inspection at the office of The Gateway Engineers, Inc., 100 McMorris Road, Pittsburgh, PA 15205-9401 where sets of said documents may be obtained upon payment of \$50.00 per set per for each contract project bid. No refund will be made for the return of any documents. There are no exceptions. Bidding documents will be available on May 8, 2023. If specifications are to be mailed, there will be an additional fee of \$20.00 per document per contract. A document is considered one contract. Digital Copies Specifications will be available upon payment of the aforementioned fee. Performance and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Hampton Township in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within 15 days after Notice of the Award of the Contract. If more time is necessary for the ascertainment of the lowest responsible bidder, Hampton Township reserves the right to award the contract at a later date, but not exceeding sixty (60) days from the date bids were submitted, and such date will be publicly announced by Council at their regular meeting held on September 27, 2023.
