AN ORDINANCE OF THE MUNICIPALITY OF BETHEL PARK, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING THE PROVISIONS FOR THE COLLECTION OF EARNED INCOME TAXES ESTABLISHED BY ORDINANCE 12-11-78A AS AMENDED BY ORDINANCE NO 11-8-99A, ORDINANCE NO 05-12-03A, ORDINANCE 11-10-03B, AND ORDINANCE 11-10-08A, AND AS SET FORTH IN CHAPTER 62, ARTICLE III, SECTIONS 62.28 ET SEQ OF THE BETHEL PARK MUNICIPAL CODE IN ORDER TO OBTAIN REVENUE IN THE PROJECTED AMOUNT OF \$12,369,000 BY LEVYING A TAX OF ONE PERCENT (1.0%) ON THE EARNED INCOME AND NET PROFITS EARNED ON OR AFTER JANUARY 1, 2024, BY RESIDENTS OF THE MUNICIPALITY OF BETHEL PARK AND ON THE EARNED INCOME AND NET PROFITS EARNED ON OR AFTER JANUARY 1, 2024, OF BUSINESS PROFESSIONS OR OTHER ACTIVITIES CONDUCTED BY RESIDENTS OF THE MUNICIPALITY OF BETHEL PARK AN ORDINANCE OF THE MUNICIPALITY OF BETHEL PARK, ALLEGHENY COUNTY, PENNSYLVANIA, FIXING THE TAX RATE FOR THE FISCAL YEAR 2024. Tax Rate for general purposes, the sum of three and nineteen hundredths (3.19) mills on each dollar (\$1.00) of assessed valuation for municipal purposes and thirty-four hundredths (.34) mills on each dollar (\$1.00) of assessed valuation for the provisions of funding to Bethel Park Volunteer Fire Company and costs associated with the same.
