NOTICE OF ORDINANCE NO. 903 & 904

On December 11, 2023, at 7:00 PM at the Borough of Jefferson Hills Municipal Building located at 925 Old Clairton Road, Jefferson Hills, PA 15025, the Borough Council shall inform and take public comment on the following proposed Ordinances: AN ORDINANCE OF THE BOROUGH OF JEFFERSON HILLS, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING THE CONDEMNATION AND TAKING BY EMINENT DOMAIN OF A FEE SIMPLE INTEREST OVER TAX MAP PARCEL NO. 1134-J-116 (COMMONLY KNOWN AS MARYLAND AVENUE, FINLEYVILLE, PA 15332) WHICH IS PROPERTY OF EDWARD HELBIG, DECEASED, FOR PUBLIC PURPOSES; AUTHORIZING THE BOROUGH SOLICITOR TO PROCEED WITH THE ACQUISITION OF A FEE SIMPLE INTEREST THEREIN THROUGH EMINENT DOMAIN; AUTHORIZING THE PAYMENT OF JUST COMPENSATION; AND AUTHORIZING THE PROPER OFFICERS OF THE BOROUGH TO UNDERTAKE SUCH ACTS AS NECESSARY TO ACQUIRE THE PROPERTY INTERESTS CONDEMNED UNDER THIS ORDINANCE. Summary of the proposed Ordinances: The proposed Ordinance sets forth the Borough's declaration of intent to condemn the property located at Maryland Avenue, Finleyville, PA 15332, parcel no. 1134-J-116.

And AN ORDINANCE OF THE BOROUGH OF JEFFERSON HILLS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING ORDINANCE 206 OF 1964, AS AMENDED, CODIFIED AS SECTION 1-101 OF THE BOROUGH CODE OF ORDINANCES TO MODIFY THE TIME OF MEETINGS TO BE HELD ON THE FIRST WEDNESDAY AND SECOND MONDAY OF EACH AND EVERY MONTH AT 7:00PM. Summary of the proposed Ordinance Amendments: The proposed Ordinance sets forth the Borough's decision to modify the day and time of the Borough's Agenda meeting to be the first Wednesday of every month. That same evening, the Borough Council will consider, and may enact, the above captioned Ordinances. The proposed ordinance amendment may be examined during normal business hours at the Municipal Building.
