CONTRACT

This project involves sanitary and storm sewer point repairs including, but not limited to: sanitary and storm sewer excavation point repairs; replacement of wye and lateral pipe; MH installation; location and adjustment of buried sanitary and storm sewer manholes; invert replacement; CCTV verification of the repair locations; and the post repair NASSCO CCTV. All traffic control, notification, and restoration of disturbed areas are also included in the project. Proposals shall be delivered in a sealed envelope that is clearly marked on the outside with the appropriate wording Shaler Township Sanitary and Storm Sewer Point Repair Contract. All proposals must be in the hands of Chris Lovato Township Manager, before 11:00 a.m. prevailing time on Wednesday, January 31, 2024, and the same will be publicly opened and read at that time at the Township Building, located at 300 Wetzel Road, Glenshaw, PA 15116.

TELEVISIONING AND CLEANING

CONTRACT

This project includes sanitary sewer televising investigations of various size pipe, including the cleaning (light and heavy), plugging/bypass pumping and manhole inspections throughout the Township. All traffic control and resident notification in work locations are also included in this project. The Township may add or subtract various sanitary sewers throughout the Contract. The Township reserves the right to renew this Contract for the 2025, 2026, and 2027 calendar years. Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words Shaler Township Sanitary Sewer Televising and Cleaning Contract. All proposals must be in the hands of Chris Lovato, Township Manager, Township Building, 300 Wetzel Road, Glenshaw, PA 15116 before 11:00 a.m. prevailing time on Wednesday, January 31, 2024 and the same will be publicly opened and read at that time.

SEWER LINING CONTRACT

This project involves sanitary and storm sewer repairs including but not limited to: sanitary and storm sewer full length manhole to manhole lining CIPP repairs; spot lining CIPP repairs; pre and post CCTV inspections; internal reinstatement of active service laterals; cutting of protruding taps; traffic control; resident and business notification; and site restoration, complete in place. All traffic control and restoration of disturbed areas are also included in this project. Proposals shall be delivered in a sealed envelope that is clearly marked on the outside with the appropriate wording Shaler Township Sanitary and Storm Sewer Lining Contract. All proposals must be in the hands of Chris Lovato, Township Manager, before 11:00 a.m. prevailing time on Wednesday, January 31, 2024 and the same will be publicly opened and read at that time at the Township Building, located at 300 Wetzel Road, Glenshaw, PA 15116.

CHEMICAL ROOT

TREATMENT CONTRACT

This project involves the chemical root treatment of approximately 23,000 LF of sanitary sewers throughout Shaler Township, complete in place. All traffic control and resident notifications are also included in this project. The Township reserves the right to renew this Contract for the 2025, 2026, and 2027 calendar years. Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words Shaler Township Chemical Root Treatment Contract. All proposals must be in the hands of Chris Lovato, Township Manager, Township Building, 300 Wetzel Road, Glenshaw, PA 15116 before 11:00 a.m. prevailing time on Wednesday, January 31, 2024 and the same will be publicly opened and read at that time.

Prevailing wages will NOT be required to be paid on this contract.

Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreement are on file and open to public inspection at the office of The Gateway Engineers, Inc., 100 McMorris Road, Pittsburgh PA 15205 where sets of said documents may be obtained on January 8th, 2024 upon payment of \$50.00 per set. No refund will be made for the return of any documents. An additional \$10.00 will be required if they are to be mailed. Electronic documents will be provided at no charge upon request. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Shaler Township in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract. The Proposals must be made to Shaler Township, Allegheny County, Pennsylvania, and shall remain firm for a period of ninety (90) days. No Bidder may withdraw his Proposal during the ninety (90) day period without forfeiting his Bid guarantee. Performance, Maintenance, and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement upon acceptance of the Proposal from the successful Bidder. The Township reserves the right to reject any or all Bids, or any part thereof, for any reason, and also reserves the right to waive any informality therein. The Bidder is advised that the Township will award the contract to the lowest responsible bidder based on the total bid submitted. However, the bidder is advised that the Township expressly reserves the right to reject all bids, and specifically reserves the right to award to the lowest responsible bidder a contract for all or any portions of the work listed in the proposal, and in awarding a contract for less than the total work listed, or less than all portions of the work listed, the contract price will be determined from the total quantities for each item listed and the unit price bid for each item listed.
