Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Collier Township in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract. A Performance Bond in the amount of one hundred percent (100%) of the Contract Value will be required upon execution of the Contract.

**Pennsylvania Prevailing Wage Rates are required to be paid on this contract.**

A non-mandatory pre-bid meeting will be held at 12:30 P.M. on March 6, 2024, at the Collier Township Municipal Building at 2418 Hilltop Road, Presto, PA 15142. **All contractors that intend to bid on the Contract are encouraged to attend.** All contractors must adhere to Act 127 of 2012 (Public Works Employment Verification Act). No bid may be withdrawn for sixty (60) days after the same has been filed with Collier Township. No Bidder may withdraw his Proposal during the sixty (60) day period without forfeiting his Bid guarantee.
