Sealed Proposals will be received by the Mt. Lebanon Commission at the Municipal Building, 710 Washington Road, Pittsburgh, PA 15228 until 2:00 pm prevailing time, on March 19, 2024 for the following:

MT. LEBANON 2024 STREET MAINTENANCE PROGRAM

Major bid items are: Milling of existing materials, ADA ramps, leveling with one (1) inch thick bituminous pavement (where applicable), 1-1/2" thick minimum bituminous overlay and bituminous binder throughout the Municipality of Mt. Lebanon.

Proposals shall be delivered in a sealed envelope that is clearly marked on the outside with the appropriate wording "2024 Street Maintenance Program" to the desk of the Director of Public Works, Rudy Sukal, Municipal Building, 710 Washington Road, Pittsburgh, PA 15228 before 2:00 pm prevailing time, March 19, 2024 delivered to the 1st Floor Service Center, and the same will be publicly opened and read at that time at the Municipal Building Commission Chambers located at 710 Washington Road, Pittsburgh, PA 15228.

Prevailing wage rates will be required to be paid on this contract.

Sealed Proposals will be received by the Mt. Lebanon Commission at the Municipal Building, 710 Washington Road, Pittsburgh, PA 15228 until 2:00 pm prevailing time, on **March 19, 2024** for the following:

MT. LEBANON 2024 ROAD RECONSTRUCTION PROGRAM

Major bid items are: New Bituminous Pavement (1 1/2" Superpave 9.5 mm Bituminous Wearing Surface, 1 1/2" Superpave 19.0 mm Bituminous Binder, and Superpave 25.0 mm Bituminous Concrete Base Course); removal and reconstruction of existing base; removal/replacement of concrete pavement; construction of roof drain collectors; removal and reconstruction of concrete curbs; handicapped ramps; construction and reconstruction of storm inlets; storm and sanitary sewer manholes, installation of new storm sewer pipe, construction of green infrastructure projects and reconfiguration of the intersection of Cedar Boulevard and Salem Drive. Proposals shall be delivered in a sealed envelope that is clearly marked on the outside with the appropriate wording "2024 Street Reconstruction Program" to the desk of the Director of Public Works, Rudy Sukal, Municipal Building, 710 Washington Road, Pittsburgh, PA 15228 before 2:00 pm prevailing time, **March 19, 2024** delivered to the 1st Floor Service Center, and the same will be publicly opened and read at that time at the Municipal Building Commission Chambers located at 710 Washington Road, Pittsburgh, PA 15228.

All bidders for both contracts must be PennDOT pre-qualified and meet the work classification and capacity rating for the types of work specified in the bidding documents. All bids submitted must have the contractor's valid pre-qualification certification attached to the outside of the bid.

A price adjustment of bituminous materials will be permitted in accordance with section 110.04 of Penn- DOT Publication 408. The Contractor shall calculate and submit their bid based on the current asphalt index for the month of the bid opening. The Contractor shall strictly adhere to the Contract schedule for executing the Contract documents, starting and finishing the project. No additional compensation will be paid if there is a delay in executing the Contract or starting construction without a time extension granted via formal change order issued by the Municipality.

Prevailing wage rates will be required to be paid on this contract.

For the above projects, Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreements are on file and open to public inspection at the office of The Gateway Engineers, Inc., 100 McMorris Road, Pittsburgh, PA 15205 where sets of said documents may be obtained on Wednesday, March 6, 2024, upon payment of \$50.00 for each contract set. A \$10 mailing fee for each set requested will be applied to any specifications which are mailed to bidders. No refund or exchange will be made for the return of any documents. Sealed Proposals will be received by the Municipality of Mt. Lebanon, Allegheny County, Pennsylvania until **2:00 pm** prevailing time, on **March 19, 2024** to be publicly opened and read immediately thereafter for the following project:

MT. LEBANON 2024 STREET REJUVENATOR PROGRAM

This project consists of the application of Reclamite pavement rejuvenator throughout the Municipality of Mt. Lebanon. The application will be approximately 34,600 SY of rejuvenator as required. The project also includes all required traffic controls, resident notification, and cleanup after completion of the project. A map of the streets to be rejuvenated will be provided at the beginning of the project.

All Proposals must be in the hands of Rudy Sukal, Director of Public Works, before **2:00 pm**, local time, on **March 19, 2024**, and the same will be publicly opened and read immediately thereafter. Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words "Street Rejuvenator Program".

Pennsylvania Prevailing Wage rates will not be required to be paid on this project.

For this project, Copies of Bidding and Contract Documents are on file and open to public inspection at the Issuing Office, The Gateway Engineers, Inc., 100 McMorris Road, Pittsburgh, PA 15205 where sets of said documents may be obtained upon payment of \$50.00 per set plus a \$10.00 shipping charge if the Bidder requests document shipping. Documents will be available beginning on **Thursday, February 29, 2024**. Office hours are Monday through Friday 8:00 A.M. to 4:00 P.M. No refund will be made for the return of any documents.

For each of the above contracts, Performance, Maintenance, and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement upon acceptance of the Proposal from the successful Bidder.

For each of the above contracts, proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Municipality of Mt. Lebanon in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within 15 days after Notice of the Award of the Contract.

The Proposals must be made to the Municipality of Mt. Lebanon, Allegheny County, Pennsylvania, and shall remain firm for a period of sixty (60) days. No Bidder may withdraw his Proposal during the sixty (60) day period without forfeiting his Bid guarantee.

The Owner reserves the right to reject any or all Proposals, or any part thereof, for any reason, and also reserves the right to waive any informality therein.
