**Base Bid** This project involves the installation of approximately 500 ft of underdrain, one French Mattress, installation of a stacked stone headwall and endwall, installation of approximately 330 tons of road base, delivery/placement/compaction of approximately 640 tons of driving surface aggregate, traffic control, resident notification, preparation, and cleanup. Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words **HUNT ROAD DRAINAGE AND RESURFACING PROJECT**.

Copies of the Request for Quote, Specifications, Technical Drawings, the Driving Surface Aggregate Manual Submission Guidelines, General Conditions, Bid Timeline, and Quote Form are on file and open to public inspection at the office of Borough of Sewickley Heights Administrative Building, 238 Country Club Road, Sewickley, Pennsylvania 15143 where sets of said documents may be obtained. The same will be made available electronically upon request. Performance and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement.

Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Borough of Sewickley Heights in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract. All proposals must be in the hands of Nathan Briggs, Borough Manager, Borough of Sewickley Heights, 238 Country Club Road, Sewickley, PA 15143 on or before Friday, April 12, 2024 at 10:00 a.m. prevailing time and the same will be opened and read publicly immediately thereafter. Proposals must be submitted in hard copy format. If more time is necessary for the ascertainment of the lowest responsible bidder, the Borough reserves the right to award the contract at a later date, but not exceeding sixty (60) days from the date bids were submitted, and such date will be publicly announced immediately after the bids are opened. The Borough reserves the right to award the contract at their sole discretion.
