
ESTER C. "PETE" CORSE, JR.

He was also a PIAA official for Swimming, Past President and Board Member of the Schuylkill County Cancer Society, and former Board Member of Schuylkill County Chamber of Commerce. He was preceded in death by his wife, Norma G. Corse on December 23, 2018; and a sister, JoAnn Stone. Surviving are two daughters, Kerry Corse Campion and her husband Thomas, Pottsville and Daun Corse Phillips, Orwigsburg; three grandchildren, Sarah Corse Campion, Jonathan Peter Phillips, Jr., and Andrew Corse Phillips.
