**DATE, TIME, AND LOCATION OF BANKRUPTCY CODE SECTION 341(a) MEETING OF CREDITORS**

DEADLINE TO FILE A COMPLAINT TO DETERMINE DISCHARGEABILITY OF CERTAIN DEBTS

CREDITORS MAY NOT TAKE CERTAIN ACTIONS IN MOST INSTANCES. THE FILING OF THE BANKRUPTCY CASE AUTOMATICALLY STAYS CERTAIN COLLECTION AND OTHER ACTIONS AGAINST THE DEBTORS AND THE DEBTORS' PROPERTY. UNDER CERTAIN CIRCUMSTANCES, THE STAY MAY BE LIMITED TO 30 DAYS OR NOT EXIST AT ALL, ALTHOUGH THE DEBTORS CAN REQUEST THE COURT TO EXTEND OR IMPOSE A STAY. IF YOU ATTEMPT TO COLLECT A DEBT OR TAKE OTHER ACTION IN VIOLATION OF THE BANKRUPTCY CODE, YOU MAY BE PENALIZED.

COMMON EXAMPLES OF PROHIBITED ACTIONS BY CREDITORS ARE: (I) CONTACTING THE DEBTORS TO DEMAND REPAYMENT; (II) TAKING ACTION AGAINST THE DEBTORS TO COLLECT MONEY OWED OR TAKING PROPERTY OF THE DEBTORS; AND (III) STARTING OR CONTINUING COLLECTION ACTIONS, FORECLOSURE ACTIONS, OR REPOSSESSIONS. CONSULT A LAWYER TO DETERMINE YOUR RIGHTS.
