This project is for all work related to the CIPP MH to MH Lining sewer repairs including, but not limited to: pre and full NASSCO post repair CCTV inspections, heavy cleaning, reinstatement of active service laterals, cutting of protruding taps, bypass pumping, traffic control and resident notification.
