BOROUGH OF FOREST

At its regular meeting to be held on Wednesday, June 19, 2024, at 7:00 p.m. at the Forest Hills Borough Building located at 4400 Greensburg Pike, Pittsburgh, PA 15221, the Council of the Borough of Forest Hills will consider the adoption of, and if appropriate enact, six separate proposed ordinances. The first ordinance is entitled

AN ORDINANCE OF THE BOROUGH OF FOREST HILLS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 1, PART 6, OF THE FOREST HILLS BOROUGH CODE OF ORDINANCES, ADMINISTRATION AND GOVERNMENT, AS AMENDED, TO REPEAL AND RESTATE SECTION 1-621, ENVIRONMENTAL ADVISORY COUNCIL, IN ITS ENTIRETY TO REESTABLISH THE ENVIRONMENTAL ADVISORY COUNCIL OF THE BOROUGH, ITS POWERS, AND DUTIES.

The second ordinance is entitled

AN ORDINANCE OF THE BOROUGH OF FOREST HILLS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 1, PART 6, OF THE FOREST HILLS BOROUGH CODE OF ORDINANCES, ADMINISTRATION AND GOVERNMENT, AS AMENDED, TO ADD A NEW SUBCHAPTER F, SECTION 1-651, TO ESTABLISH AN ARTS AND CULTURE ADVISORY COUNCIL OF THE BOROUGH, ITS POWERS, AND DUTIES.

AN ORDINANCE OF THE BOROUGH OF FOREST HILLS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 1, PART 6, OF THE FOREST HILLS BOROUGH CODE OF ORDINANCES, ADMINISTRATION AND GOVERNMENT, AS AMENDED, TO REPEAL AND RESTATE SECTION 1-611, RECREATION BOARD, IN ITS ENTIRETY TO REESTABLISH THE PARKS AND RECREATION ADVISORY COUNCIL OF THE BOROUGH, ITS POWERS, AND DUTIES.

The sixth ordinance is entitled

AN ORDINANCE OF THE BOROUGH OF FOREST HILLS, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 1, PART 5, ARTICLE D, REAL ESTATE TAXES, MUNICIPAL CLAIMS, AND OTHER MUNICIPAL FEES, TO ADOPT INTEREST, PENALTIES AND A SCHEDULE OF ATTORNEY FEES IN CONNECTION WITH THE COLLECTION OF TAXES, TAX CLAIMS, TAX LIENS, MUNICIPAL CLAIMS, MUNICIPAL LIENS, AND OTHER MUNICIPAL FEES PURSUANT TO ACT 1 OF 1996 AND ACT 20 OF 2003 AND ADOPTING A SCHEDULE OF CHARGES, EXPENSES, AND FEES PURSUANT TO THE ACT OF MAY 16, 1923, AS AMENDED, 53 P.S. §7101, §7103, AND §7106, INCLUDING ACT 83 OF 2004.
