The Bids will be publicly opened and read aloud shortly thereafter the same day at the same place. Bids received after the stated time will be returned unopened. The Project consists of improvements to the Authority's rain garden at their wastewater treatment plant, including installing 12" PVC pipe, saw cutting existing asphalt, and replacing with asphalt curb, and removal of vegetation and replanting in the rain garden. Each Bid shall be accompanied by a certified check, bank money order, or a Bid Bond in an amount not less than 5 percent of the Bid total, payable to the Owner in accordance with the Instructions to Bidders.
