**2024 TRAFFIC SIGNAL
IMPROVEMENTS**

The scope of work includes the placement of new vehicle/pedestrian signal heads, a pedestrian stub pole, conduit and wiring, a controller cabinet, a time clock, an uninterruptible power supply (UPS) as-sembly, radar detectors, an acoustic preemption system, pavement markings, street signs, pedestrian amenities, traffic control for two existing traffic signals and all necessary appurtenances and restora-tion for said construction at the intersections of McKee Drive and PTC Road, along with the intersec-tion of Steubenville Pike and Mahoney Road. All bidders are required to buy the Bid Documents in PDF format for a non-refundable deposit of \$175.00 from QuestCDN at www.questcdn.com using project number 9228525. Contact their Custom-er Support regarding membership registration, downloading and working with digital project infor-mation at 952-233-1632 or info@questcdn.com. Any technical questions regarding the bid documents are to be directed to LSSE. Pennsylvania prevailing wage rates apply. Proposals must be upon the forms furnished by the Town-ship. The bid must be accompanied by a certified check or bid bond in the amount of ten percent (10%) of the bid, made payable to the Township of North Fayette to guarantee the bidder's entrance into the contract if given the award. The Township reserves the right to reject any or all proposals and to waive any informalities in the bid-ding. No bid may be withdrawn for ninety (90) calendar days after the scheduled time for receipt of bids. Attention is directed to the fact that procurement is subject to all requirements of the Pennsylvania "Steel Products Procurement Act, Act No. 1978-3"; and for Contract value exceeding \$25,000, the Pennsylvania Prevailing Wage Act (Act of 1961 P.L. 987), and The Public Works Employment Verification Act (July 2012) apply. The Township shall (a) award the construction contract to the lowest responsible bidder therefore, or (b) reject all bids received within ninety (90) days of the date of bid opening; provided, however, that the Township may, in its sole discretion, delay such award or rejection for up to one hundred twenty (120) days from the bid opening date until the Township has received all required approvals from other governmental agencies. Bidders on this work will be required to comply with Title VI of the Civil Rights Act of 1964.
