"JACK"



Age 94, of Upper St. Clair, peacefully passed away on Friday, July 26, 2024, with his family by his side. He is survived by his beloved wife, Claire (Sullivan) for over 69 wonderful years. He started working at his grandfather's bar on the North Side at age 12 and continued working until he retired from the practice of law at age 85. Jack began his law career at Mercer & Buckley and then formed his own law firm, Sharlock & Repcheck. He was primarily a civil defense attorney and was very active in asbestos litigation, serving as national counsel for one of the major defendants.

Jack had a very strong Catholic faith and served on the Parish Council for St. Louise de Marillac and later became a member of St. John Capistran parish. Jack and Claire enjoyed traveling, especially to Hilton Head, SC where they owned a vacation home for many years. Jack was also a long-time member of St. Clair Country Club. He will be remembered for his generosity, huge heart, and most of all, love for his family. He worked very long hours and shouldered a lot of responsibility but never missed a performance or game and rarely missed family dinners. He will be dearly missed by all.
