Chad was also a member of the Pirates Eantasy Camp Hall of Fame and also a member of the Pirates Fantasy Camp Hall of Fame and was scheduled to attend this year's camp again in December. He was a proud member of that fraternity and cultivated close friendships with his fellow campers.
