**AN ORDINANCE OF THE  
BOROUGH OF HEIDELBERG,  
ALLEGHENY COUNTY,  
PENNSYLVANIA,  
AMENDING AND  
REPEALING, IN PART,  
CHAPTER 95 OF THE  
BOROUGH OF HEIDELBERG  
CODE OF ORDINANCES,  
STREETS AND SIDEWALKS  
TO REPEAL PART 1  
APPENDIX I AND REPLACE  
IT WITH ALTERNATIVE PART  
1 APPENDIX I.**

**WHEREAS**, Council for the  
Borough of Heidelberg  
("Borough") acknowledges the  
value of street openings; and

**WHEREAS**, Council for the  
Borough has the authority to  
enact and amend provisions  
of the Code of Ordinances of  
the Borough (the "Code") at  
any time it deems necessary  
for the health, safety, morals,  
cleanliness, beauty,  
convenience, comfort and  
general welfare of the  
Borough and the inhabitants  
thereof; and

**WHEREAS**, the Heidelberg  
Borough Code of Ordinances  
(the "Code"), Chapter 95,  
regulates Streets and  
Sidewalks in the Borough; and

**WHEREAS**, the Council for the  
Borough deems it necessary  
to amend the Code to allow  
street opening and excavation  
to extend beyond the center  
line of a street.

**NOW, THEREFORE, BE IT  
ORDAINED AND ENACTED  
BY THE COUNCIL OF THE  
BOROUGH OF HEIDELBERG,  
ALLEGHENY COUNTY,  
PENNSYLVANIA, AND IT IS  
HEREBY ORDAINED AND  
ENACTED BY AND WITH  
THE SAME THAT:**

**SECTION 1:**  
Chapter 95, Streets and  
Sidewalks, Part 1, Appendix I  
of the Code, Bituminous Street  
Opening Detail is hereby  
repealed.

**SECTION 2:**  
Chapter 95, Part 1 of the  
Code, Appendix I, Bituminous  
Street Opening Detail is  
hereby replaced with  
Alternative Part 1, Appendix I,  
Bituminous Street Opening  
Detail attached hereto.

**SECTION 3:**  
Any Ordinance or part thereof  
in conflict herewith, is hereby  
repealed to the extent of said  
conflict.

**SECTION 4:**  
The Council for the Borough  
are hereby authorized and  
directed to execute any and  
all documents necessary to  
effectuate the purposes of this  
Ordinance.

**SECTION 5:**  
This Ordinance shall become  
effective on the date that it is  
passed by the Council for the  
Borough.
