Separate and sealed proposals will be received by Ross Township, Allegheny County, Pennsylvania, at the Ross Township Department of Public Works Building located 225 Cemetery Ln, Pittsburgh, PA 15237, until 11:30 A.M., prevailing time, on January 21st, 2025, at which time they will be opened and read for the following project:

### **ROSS TOWNSHIP MANHOLE REHABILITATION – 3 YEAR RENEWAL CONTRACT**

#### **Contract 4/2025**

This project involves manhole rehabilitation including manhole lining using polyurea lining; active infiltration control; invert removal and replacement; manhole frame and lid resetting; as well as traffic control, resident notifications, and any necessary restoration. **The Owner reserves the right to renew the Contract for the 2026 and 2027 calendar years.**

Contract Documents, including Drawings and Detailed Specifications must be obtained at the office of Gibson-Thomas Engineering, 9951 Old Perry Highway, Wexford, PA 15090 between the hours of 9:00 a.m. and 4:00 p.m., **upon a non-refundable payment of \$100.00** (plus a \$15.00 postage & handling fee if mailed at Gibson-Thomas Engineering's cost) for each set of contract documents. All checks must be made payable to Gibson-Thomas Engineering Co.

Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the Contract Number in the lower left corner and bearing the words "**ROSS TOWNSHIP – MANHOLE REHABILITATION – 3 YEAR RENEWAL CONTRACT**" to the Ross Township Department of Public Works Building located 225 Cemetery Ln, Pittsburgh, PA 15237.

Proposals must be submitted on the forms provided. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Ross Township in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract.

**Pennsylvania Prevailing Wage Rates are required to be paid on this contract.**

A **mandatory** pre-bid meeting will be held on January 14th, 2025, at 12:30 P.M. at the Department of Public Works Building located at 225 Cemetery Lane, Ross Township, PA 15237. **All contractors that intend to bid on the Contract must attend.**

All contractors must adhere to Act 127 of 2012 (Public Works Employment Verification Act). No bid may be withdrawn for sixty (60) days after the same has been filed with Ross Township. No Bidder may withdraw his Proposal during the sixty (60) day period without forfeiting his Bid guarantee.

The Owner reserves the right to reject any of all bids or to waive any informality in bids received.
