Separate and sealed proposals will be received by Ross Township, Allegheny County, Pennsylvania, Department of Public Works Building located at 225 Cemetery Lane, Ross Township, PA 15237, until 11:15 A.M., prevailing time, on January 21st, 2025, at which time they will be opened and read for the following project:

ROSS TOWNSHIP 2025 PAVING PROGRAM Contract 5/2025

This project involves the milling and bituminous paving of streets within Ross Township, including, but not limited to rotomilling, installation of ID-2 asphalt, installation of bituminous wedge curb, inlet and manhole adjustments, line striping, traffic control, and restoration.

Proposals must be submitted on the forms provided. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Ross Township in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract.

Pennsylvania Prevailing Wage Rates are required to be paid on this contract.

A **mandatory** pre-bid meeting will be held on January 14th, 2025, at 12:00 P.M. at the Department of Public Works Building located at 225 Cemetery Lane, Ross Township, PA 15237. **All contractors that intend to bid on the Contract must attend.**

All contractors must adhere to Act 127 of 2012 (Public Works Employment Verification Act).

No bid may be withdrawn for sixty (60) days after the same has been filed with Ross Township. No Bidder may withdraw his Proposal during the sixty (60) day period without forfeiting his Bid guarantee.

The Owner reserves the right to reject any of all bids or to waive any informality in bids received.
