**YEARLY CONCRETE CURB**

**MAINTENANCE PROGRAM**

This project includes the removal and replacement of various sizes of concrete straight curb, concrete roll curb, and concrete curb and gutter throughout the Municipality.

Bidder will enter into an

Agreement within 15 days

after Notice of the Award of

the Contract. For all the above

contracts, the Proposals must

be made to the Municipality of

Mt. Lebanon, Allegheny

County, Pennsylvania, and

shall remain firm for a period

of sixty (60) days. No Bidder

may withdraw his Proposal

during the sixty (60) day period

without forfeiting his Bid

guarantee. The Owner

reserves the right to reject any

or all Proposals, or any part

thereof, for any reason, and

also reserves the right to

wave any informality therein.
