

**NOTICE TO BIDDERS

Sealed Proposals will be received by the Municipality of Bethel Park 5100 West Library Avenue, Bethel Park, PA 15102 until 9:30 A.M. prevailing time on Wednesday, February 12, 2025 for the following projects:

2025 SANITARY SEWER REPAIR PROJECT

This project includes approximately 15 sanitary sewer excavation repairs throughout the Municipality of Bethel Park. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 SANITARY SEWER REPAIR PROJECT. Prevailing wage rates are required to be paid on this project.

2025 STORM SEWER REPAIR PROJECT

This project includes the rehabilitation of storm sewers, inlets, MS4 outfalls, and storm structures throughout the Municipality of Bethel Park. This also includes the removal and stabilization of a retaining wall, installation of endwalls, along with fill, and regrading of slope. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 STORM SEWER REPAIR PROJECT. Prevailing wage rates are required to be paid on this project.

2025 SANITARY SEWER CCTV & MANHOLE INSPECTION PROJECT

This project includes the cleaning and (CCTV) Closed Circuit Televising of approximately 100,000 LF of sanitary sewers throughout the Municipality of Bethel Park. This project also includes the inspection of approximately 450 manholes associated with the CCTV locations. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 SANITARY SEWER CCTV & MANHOLE INSPECTION PROJECT.

2025 STORM SEWER CCTV INSPECTION PROJECT

This project includes the cleaning and (CCTV) Closed Circuit Televising of approximately 24,115 LF of storm sewers throughout the Municipality of Bethel Park. This project also includes the heavy cleaning of approximately 4,000 LF of storm sewer identified by CCTV locations. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 STORM SEWER CCTV INSPECTION PROJECT.

2025 SANITARY SEWER LINING PROJECT

This project includes the lining of approximately 65 segments of sanitary sewers throughout the Municipality of Bethel Park. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 SANITARY SEWER LINING PROJECT. Prevailing wage rates are required to be paid on this project.

2025 MANHOLE REHABILITATION PROJECT

This project includes the rehabilitation of approximately 70 sanitary manholes throughout the Municipality of Bethel Park. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 MANHOLE REHABILITATION PROJECT. Prevailing wage rates are required to be paid on this project.

2025 ROAD PAVING PROJECT

This project includes storm sewer work and resurfacing of roadways throughout the Municipality of Bethel Park. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 ROAD PAVING. Prevailing wage rates are required to be paid on this project.

2025 LANDSCAPING PROJECT

This project includes the yard restoration behind curbs associated with the 2025 Road Paving. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 LANDSCAPING PROJECT.

2025 ROAD REJUVENATOR PROJECT

This project includes the rejuvenating of approximately 129,000 SY of asphalt pavement throughout the Municipality of Bethel Park. Proposals shall be delivered in a sealed envelope, clearly marked on the outside with the words 2025 ROAD REJUVENATOR PROJECT.

All Proposals must be in the hands of Lou Lambros, Engineering Dept., 5100 West Library Avenue, Bethel Park, PA 15102, on or before February 12, 2025 at 10:30 A.M. prevailing time where the same will be publicly opened and read immediately thereafter.

There will be a **Mandatory** Pre-bid meeting for the Road Paving & Landscaping projects on Tuesday, February 4, 2025 at 10:00 AM in Municipal Building - Council Chambers, 5100 West Library Avenue, Bethel Park, PA 15102. Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreement for each Project are on file and open to public inspection at the office of 5100 West Library Avenue, Bethel Park, PA 15102 where sets of said documents may be obtained upon payment of fifty (\$50.00) dollars per set. A fifteen (\$15.00) dollar fee shall be applied if documents are to be mailed. No refund will be made for the return of any documents. Electronic files may be requested at no cost. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Municipality of Bethel Park, Allegheny County, Pennsylvania in an amount equal to ten (10%) percent of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract. Proposals must be made to the Municipality of Bethel Park and shall remain firm for a period of sixty (60) days. No Bidder may withdraw their Proposal during the sixty (60) day period without forfeiting the Bid guarantee. Performance and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement. Bidders are advised that the Municipality will award each contract to a single qualified, responsive, and responsible Bidder for each Contract based on the lowest Base Bid and any combination of Alternates chosen by the Municipality at its sole discretion. However, Bidders are advised that the Municipality expressly reserves the right to reject all bids, and specifically reserves the right to award to the lowest qualified, responsive, and responsible Bidder a contract for all or any portions of the work listed in the proposal, and in awarding a contract for less than the total work listed, or less than all portions of the work listed, the contract price will be determined from the total quantities for each item listed and the unit price bid for each item listed. The Municipality also reserves the right to reject any or all Proposals, or any part thereof, for any reason, and reserves the right to waive any informality therein.
