Ira was the youngest of two children and the only son of Ira C. Houck, Sr. and Mary Swartz. Elizabeth He was his sister. predeceased bv Marvann Brown. Gibsonia, raised in and graduated from Mars High School at age 16. Ira joined United States Marine Reserves. where served honorably for more than 40 years, retiring as a full colonel. At just 22 years old, he was a Second Lieutenant and a graduate of the Marine Corps' first-ever Platoon Leader's Class. During his tour, he earned two Purple Hearts and was engaged in a fierce firefight known in Marine Corps history as "the Battle of Horseshoe Ridge." Upon returning home, Ira enrolled a the University of Dittsburgh School of Law and rounited with University of Pittsburgh School of Law and reunited with Jeannine to begin their life together. Over the next 10 years, the couple had five children, Ira C. Houck, III ("Ike") (Margaret McKenna), Elizabeth Ann Houck ("Bitsy") (Tom Springston), Patricia Susan Yannie ("Trish") (Mark Yannie), Jon Maitland Houck ("Big Jon") and David Kennedy Houck (Loriann Kelly). As a practicing attorney, Ira co-owned and was a partner at his law firm, Breuck and Houck. In 1969, he played a key role in establishing the Allegheny County Public Defender's Office, where he later served as Chief Public Defender in 1996. Beyond his legal career, Ira also became an ordained Anglican priest and faithfully served as clergy at Grace Anglican Church on Mt. Washington for many years. Among his many adventures, he took up marathon running in his 40s, qualifying for and completing the Boston Marathon twice. At age 81, Ira rode the entire 184.5-mile Chesapeake and Ohio Canal Towpath (C&O Canal Towpath) from Cumberland, Maryland, to Washington, D.C.
