Representatives in the General Assembly to Fill Vacancies in 35th Legislative District.

In accordance with the general provisions of the Pennsylvania Election code, notice is hereby given to the electors of 35th Legislative District that a Special Election will be held in said districts on Tuesday, March 25, 2025. The vacancy to be filled are for the unexpired term of the Honorable Matthew R. Gergely. This Special Election will be held between the hours of 7:00 a.m. and 8:00 p.m. prevailing time at the several election districts herein. The 35th Legislative District is composed of the Cities of Clairton, Duquesne and McKeesport, the Boroughs of Homestead, Liberty, Lincoln, Munhall, Port Vue, Versailles, West Homestead, West Mifflin (Districts 3, 4 and 15), Whitaker, White Oak, and the Township South Versailles. In these Special Elections, all registered voters regardless of political party affiliation are entitled to vote.
