### Justices weigh legal arguments as Ohio wants to resume enforcing strict abortion law

Ohio Supreme Court justices vigorously questioned the state's lawyer Wednesday about a legal strategy that Ohio is attempting in hopes of reviving its law banning on abortions except in the earliest weeks of pregnancy.

Before Ohio Solicitor General Benjamin Flowers even finished the first sentence of his argument, justices began peppering him with technical questions that suggested they may be reticent to step in and lift a county judge's order that has been blocking the law since last October. The state is also challenging whether Preterm Cleveland and other Ohio clinics have the necessary legal standing

Mr. Flowers argued that the state has the right to appeal Hamilton County Common Pleas Judge Christian Jenkins' order if it can show it's suffering "irreparable harm" while the law is on hold. Mr. Flowers said each abortion that takes place that would have been prevented under Ohio's 2019 ban constitutes such harm.

The law, signed by Republican Gov. Mike DeWine in April 2019, prohibits most abortions once cardiac activity can be detected, which can be as early as six weeks into pregnancy, before many women know they're pregnant. The legal battle over the law comes as a proposed constitutional amendment that would protect abortion access in Ohio will go before voters in November.

'The problem with the First District's ruling (denying Ohio's request to appeal Judge Jenkins' order) is that, if it's right, then all 88 (county) common pleas courts can unilaterally, indefinitely suspend operation of state law for as long as it takes to conduct discovery, to hold the trial and issue an injunction," Mr. Flowers

told the court.

#### Winner of \$1.6B Mega Millions claims prize

The winner of the \$1.6 billion Mega Millions jackpot in August — the third largest in U.S. history—has come forward to claim the prize, officials said Wednes-

In all, Mega Millions has had five prizes of more than a billion dollars.

Under a new Florida law. the winner's name remains anonymous for 90 days from the date the prize was claimed, which was on Sept. 25, lottery officials said in an email. The lottery did not confirm whether the winner took the lump sum or the annuity, and did not specify the estimated lump sum amount.

In Florida, winners have to claim the lump sum within 60 days of the drawing. They have up to 180 days if they choose to go with an annuity, which is paid out in 30 annual installments. The jackpot is also subject to federal taxes. There's no state income tax in Florida.

The winning ticket was sold at a Publix supermarket in Neptune Beach, a town along the Atlantic Coast near Jacksonville.

#### Russia says Ukraine's allies aided attack

Russia on Wednesday accused Ukraine's Western allies of helping plan and conduct last week's missile strike on the Black Sea Fleet's headquarters on the annexed Crimean Penin-

"There is no doubt that the attack had been planned in advance using Western intelligence means, NATO satellite assets and reconnaissance planes and was implemented upon the advice of American and British security agencies and in close coordination with them,'

Russian Foreign Ministry spokeswoman Maria Zakharova said at a briefing.

Moscow has repeatedly claimed that the U.S. and its NATO allies have effectively become involved in the conflict by supplying weapons to Ukraine and providing it with intelligence information and helping plan attacks on Russian facilities.

Unconfirmed news reports said Storm Shadow missiles provided to Ukraine by the U.K. and France were used in the attack on the headquarters.

#### **Israelis can travel** to U.S. without a visa

The Biden administration announced Wednesday that it would allow Israeli citizens to enter the United States without a visa, a step toward improving relations between the two nations at a time when President Joe Biden is engaged in complex diplomacy with Israel on a range of is-

The move means Israel must take reciprocal actions toward American citizens, including Palestinian Americans who often face difficulties in traveling to Palestinian territories to see family members and friends.

Administration officials said the Homeland Security Department agreed to accept Israel into the U.S. government's visa waiver program after monitoring a pilot effort since July, when the two countries signed a memorandum of understanding. Since July 20, Israel has allowed more than 100,000 U.S. citizens, including tens of thousands of Palestinian Americans, to enter Israel without a visa, the officials said.

Any U.S. citizen trying to visit the West Bank can now fly into Ben-Gurion International Airport in Tel Aviv, Israel, and travel to the Palestinian territory overland, the officials said.
